#### NATIONAL MEMORIAL CEMETERY OF ARIZONA

In 1926, Mr. Ivan Williams a long-time member of the American Legion contacted U.S. Senator Henry F. Ashurst about another National Veterans' Cemetery in Arizona. In the following years hundreds of veterans joined in the effort to accomplish this task, but their efforts were in vain due to the fact that the National Cemetery in Prescott was still open for burials.

In 1970 Department Commanders of the three major Veterans Service Organizations, with full support of their predecessors and membership, pledged to establish a State Veterans Cemetery with the ultimate goal of becoming a National Cemetery.

A corporation was formed to acquire land for this purpose and Phoenix attorney, Anthony O. Jones was named the corporation attorney responsible for drafting the petition and guiding it through proper channels. Land Commissioner, Andrew L. Bettwy was diligent in working with the corporation leaders and a section of land was eventually located in Phoenix at Cave Creek and Pinnacle Peak Roads that was deemed acceptable on a lease fee basis.

The commanders presented the information to their organizations and requested approval for and obligation of the organizations to pay lease fees on the full section of land while seeking a governing authority.

State Law was passed in 1976 and signed by Governor Raul Castro authorizing development of up to six hundred forty acres for a Veterans Cemetery with \$50,000 being appropriated. Seventeen acres of the leased land was conveyed to the Arizona Department of Economic Security (DES) with twelve and a half acres to be developed initially.

The Arizona Veterans' Memorial Cemetery was dedicated December 9, 1978, with first burials occurring on March 14, 1979. A total of \$291,700 was received from the U. S. Veterans' Administration Federal-State Matching Funds Grant Program for construction improvements. The State Legislature created the Arizona Veterans' Service Commission (AVSC) in 1982 and operation of the cemetery was transferred to AVSC from DES.

In 1985, an additional two hundred twelve acres were conveyed to the AVSC bringing the cemetery acreage to two hundred twenty-five acres. In 1988 the legislature appropriated \$300,000 for capital improvements. Additional improvements where authorized and completed through donated funds of many veterans, fraternal and other service organizations.

The cemetery with burial space available for 200,000 graves was transferred to the Veterans Administration on April 1, 1989. The three Department Commanders were: Disabled American Veterans Commander George E. Egel; Veterans of Foreign Wars Commander Charles "Chuck" G. Hastings, and American Legion Commander James J. Murphy.

#### **Governor of Arizona**



Governor Doug Ducey was elected on November 4, 2014 and was sworn into office on January 5, 2015, becoming Arizona's 23rd Governor.

As governor, Ducey's priorities are growing the economy, creating jobs, improving outcomes in K-12 education and balancing the budget. A champion of limited government, economic development and Arizona businesses and families, Governor Ducey has pledged to work every day to ensure "Opportunity for All."

Prior to taking his oath as governor, Ducey served as Arizona's 32nd state treasurer, a position he held since his oath of office in January 2011. As Arizona's chief banker and investment officer, Ducey managed more than \$13 billion and served as an investment manager for level provider. The also served as a hairman of Arizona's State Board of

in state assets and served as an investment manager for local governments. He also served as chairman of Arizona's State Board of Investment and State Loan Commission, as Arizona's Surveyor General and was a member of the State Land Selection Board.

As state treasurer, Ducey notably led the opposition of Proposition 204, a tax increase that would have cost Arizona taxpayers \$1 billion per year. With Ducey's leadership, the proposition was soundly defeated by a nearly two-to-one margin. During his tenure, Ducey also oversaw the Permanent Land Endowment Trust Fund. Under his watch, the trust fund surpassed \$5 billion for the first time, with 90 percent of the earnings allocated toward K-12 education.

Before being elected state treasurer, Ducey was chief executive officer of Cold Stone Creamery. An Arizona-born concept, Cold Stone expanded from a handful of locations to more than 1,400 worldwide under Ducey's management.

Governor Ducey was born in Toledo, Ohio. He moved to Arizona to attend Arizona State University's business school, where he earned his bachelor of science in finance in 1986. Governor Ducey and his wife, Angela, live in Phoenix with their three sons, Jack, Joe and Sam.

#### **Arizona Department of Veterans' Services Director**



Arizona Department of Veterans' Services Director Wanda Wright is the third generation of her family to serve in the U.S. military. She has three decades of military experience. As a 1985 United States Air Force Academy graduate, Colonel Wright began her military career as Deputy Budget officer with the Tactical Air Command at Myrtle Beach, South Carolina with a follow-on assignment to Davis-Monthan AFB as the Budget Officer.

Leaving active duty in 1990, Colonel Wright joined the Arizona National Guard. During the next 21 years, she served in various positions including accounting and finance officer, communications officer, executive officer and, finally,

as the Director of Staff for the Adjutant General in Phoenix. Among her proudest achievements was to serve as Air Commander of Operation Jump Start from June 2006 – December 2008 during which she commanded more than 4,000 airmen from 52 states and territories on our Southwest border.

Colonel Wright holds a B.S. in Management from the U.S. Air Force Academy, a M.B.A. from Webster University in South Carolina, a M.P.A. from the University of Arizona and is completing her M.A. in Educational Leadership from Arizona State University. Colonel Wright's decorations and awards include the Legion of Merit, the Meritorious Service Medal with oak leaf cluster and the Air Force Commendation Medal.

#### Former Maricopa County Attorney



Rick Romley served four elected terms as the Maricopa County Attorney [1989-2004] and was appointed as interim Maricopa County Attorney in 2010. He has testified before the United States Senate and the United States House of Representatives on the issues of violent crime, terrorism, drug trafficking, youth violence, public corruption and victims' rights. For these efforts, Rick has been the recipient of over 100 awards.

Since leaving office, Rick started his own firm. Clientele have included former Secretary for Veterans Affairs, James Nicholson, who asked Rick to come to Washington D.C. and be his Personal Advisor to oversee the data loss of personal information for over twenty-six million veterans and to enhance the VA's security protocols and infrastructure.

Rick and his wife, Carol, live in Scottsdale, Arizona. Rick joined the United States Marine Corps as a youth and served as a combat infantry squad leader in Vietnam until wounded in 1969. Rick received numerous commendations, including the Purple Heart. In 2001, Rick received two additional National Awards for his service in defense of our country: Life's Presidential Unsung Hero Award and America's Outstanding Disabled American Veteran of the Year. Mr. Romley was inducted into the Arizona Veterans Hall of Fame in 2007.

#### Director National Memorial Cemetery of Arizona



Jerry Rainey was named director of the National Memorial Cemetery of Arizona on Sept 8, 2012. As director, he is responsible for all burial and maintenance operations at the National Memorial Cemetery of Arizona and Prescott National Cemetery.

Prior to his appointment, Mr. Rainey was the director of Eagle Point National Cemetery from March 1, 2009. He also served as assistant director at Houston National Cemetery in Texas from September 2007 to February 2009.

Mr. Rainey served four years in the U.S. Air Force and retired from the U.S. Army in May 2000. He received two Meritorious Service Medals, the Army Commendation Medal, two Army Achievement Medals, and the Expert Field Medical Badge, among other decorations.

#### MEMORIAL DAY REMEMBERED

- 1866 Columbus, GA, and Columbus, MS, formed the first Memorial Association to care for graves of Union and Confederate War dead.
- 1867 May 5<sup>th</sup>, Waterloo, NY, closed its' businesses, flew the flag at half-staff, and decorated graves of fallen soldiers.
- 1868 May 5<sup>th</sup>, General John A. Logan, first Commander-in-Chief, Grand Army of the Republic, issued a general order providing for a nationwide observation of Decoration Day on May 30<sup>th</sup>.
- Public law, 90-363 called for a uniformed annual observance of Memorial Day on the last Monday of May.
