### OFFICERS REPORTS

#### **Events Coordinator – Don Unser**

Don reported that the Base participated in the parade in Congress, AZ on Saturday October 4<sup>th</sup>. Those who attended had at a great time and our float won 1<sup>st</sup> Prize this year.

Thursday November 6<sup>th</sup> we will be having a static display in Gilbert for their annual Veterans Day Patriotic Program at the Gilbert City Hall. The ceremony and program starts at 1100. We will be getting there about 0830-0900 for parking and staging the float. Maps and information will be published in a FLASH message.

Saturday November 8<sup>th</sup> we will NOT have our meeting here. Instead, we will be participating in the Daisy Mountain Veterans Day parade which starts around 1000. We will be staging around 0700. After the parade, we then go to Black Canyon City (about 15 miles N, on I-17) and set up the float for their parade which starts at 3:00 pm. Because of the two hour wait between the two parades most of us usually stop and have lunch at the Rock Springs Cafe as you enter Black Canyon City.
